Profile of the Our Child Foundation

The Our Child Foundation was founded on 1 October 1993. Its aim is to help abused, sexually exploited and otherwise at-risk children in life-affecting situations. Since it was founded nineteen years ago, the Our Child Foundation has been associated with its founder. Zuzana Baudyšová, who has also founded the first significant project of the foundation, the so-called Safety Line. The aim of the Safety Line was to help children in lifeaffecting situations. Eventually the Parent Line and the Call Home Line were founded. The foundation had operated these crisis intervention lines for ten vears before it transferred these projects. in 2004, to the organisation Sdružení Linka bezpečí (Safety Line Association).

The foundation eventually expanded its activities to include disabled and abandoned children from socially disadvantaged families. The foundation supports, via grant proceedings, dozens of civic associations and day care centres which take care of disabled children. In addition, it finances selected activities for children from children's homes around the country and processes individual applications for urgent assistance provided to disabled and at-risk children. Since 2005 the foundation operates the Legal Aid Line which helps families and children in crisis situations. Lawyers employed by the Legal Aid Line provide free-of-charge legal consultations in the field of family law and child protection. Due to the increasing popularity of the Internet and its negative aspects, the foundation is also concerned, since 2007, with the elimination of child pornography on the Internet by operating the so-called Internet Hotline.

The foundation's key long-term activities also include edification in the field of child protection. The foundation sees child protection as a public issue. Every single person may, and should, do what they can. Therefore, the foundation offers educational programmes aimed at positive parenting.

Every year the Our Child Foundation confers on notable child protectors the annual Golden Heart Award. The Golden Heart Award is dedicated to the founder of child psychology in the Czech Republic, Professor Zdeněk Matějíček. It has so far been awarded to Czech ombudsman Pavel Varvařovský, director of the Crisis centre for children (Dětské krizové centrum) Zora Dušková, founder of the "babybox" project Ludvík Hess, Chairwoman of the Fund for Children in Need Marie Vodičková, psychologist Jiřina Prekopová or illustrator and author of the famous cartoon character "The Mole" (Krteček) Zdeněk Miler etc.

Director of the Our Child Foundation Zuzana Baudyšová frequently appears in the media or at discussion panels and forums in the Czech Republic and abroad to talk about the protection of the rights of children. As a member of the Committee for the Rights of the Child of the Government Council for Human Rights she offers her experience to improve the protection of human rights in the Czech Republic.

Activities aimed at helping children in 2012

A CHILD'S SMILE

The ROSSMANN company and the Our Child Foundation helped children with burn injuries

Burns are some of the most serious injuries sustained by children. They are very painful and their treatment is lengthy, with numerous possible complications and side effects. Children who sustain burn injuries often have permanent consequences. The ROSSMANN company and the Our Child Foundation decided to help burn centres around the country. An amount of CZK 2,716,442 was donated, via individual applications, for the purchase of state-of-the-art equipment which can significantly contribute to the saving of lives of children with burn injuries.

The financial resources used to modernise burn centres were collected during the 4th annual charity drive entitled A Child's Smile. During one week in September, customers of ROSSMANN drugstores could purchase products bearing the logo of the "smile". Over the last four years the amount of CZK 25,476,025 was collected for specific projects aimed at helping children. Help is on its way to hospitals in Prague, Brno and Ostrava

Královské Vinohrady University Hospital in Prague

The burn ward of the Královské Vinohrady University Hospital in Prague is the only "superspecialised" facility in the country that takes care of patients with burn injuries. A total of 300 children are admited each year. Special equipment known as MEEK machine was purchased for this department for CZK 300,000. Further financial assistance in the amount of CZK 1,000,000 will be provided in 2013. It will be used for renovation and equipment of the emergency room for children.

The MEEK machine was successfully used to treat Daniel (8). "We used this equipment at our burn centre to save the life of eight year-old Daniel who sustained burn injuries on 90% of the total body surface area. This device can be used to divide an excised piece of healthy tissue into 196 squares sized 3 x 3 mm and apply these pieces onto the burned skin once the dead tissue has been removed," says Robert Zajíček, Chief of Medicine of the children's ward of the burn centre of the Královské Vinohrady University Hospital.

University Hospital Brno

The Clinic for Burns and Reconstructive Surgery of the University Hospital Brno received a unique device under the name Versajet II and rehabilitation devices valued at CZK 600,000 from the proceeds from the aforementioned charity project. Versajet II is used for selective removal of dead and infected tissue from skin wounds (burns as well as chronic infected wounds) without damaging viable tissue underneath the defect. It uses a jet of fluid whose effect is similar to that of a scalpel.

"Second-degree burns are commonly treated with Versajet II. This type of burns is most common in children," adds Professor Pavel Brychta, Head Physician at the Clinic for Burns and Reconstructive Surgery, University Hospital Brno.

University Hospital Ostrava

The burn centre of the University Hospital Ostrava is one of three specialised burn centres in the country. Both devices, the total value of which exceeds CZK 1,800,000, were used for the first time shortly after commencement and they have so far been used several times to treat child patients.

The VeinViewer device can detect and display veins in subcutaneous tissue. When it comes to children with burn injuries, a subcutaneous vein must be found in order to apply special IV drip with anti-shock therapy effects and other treatment (e.g. painkillers). Even though doctors and nurses are as sensitive as they can be, this procedure is always associated with discomfort and increased post-injury stress for the child. "Thanks to VeinViewer, we can significantly reduce the time needed to apply the venoclysis cannula and, therefore, to reduce the stress reaction in child patients," says Hana Klosová, Head Physician of the burn centre in University Hospital Ostrava, about the benefits of the new equipment.

Post-injury scars in patients with burn injuries may represent permanent consequences. These scars are usually bigger and hypertrophic, dark red, stiff, painful and itchy. According to Dr. Klosová, laser therapy is a highly effective method of treatment of scarring, as documented by, and published in, numerous clinical studies. "Thanks to the Fotona XS Dynamis laser, we want to provide to our child patients the best and most effective treatment of scarring resulting from burn injuries, as these scars can have both functionally and cosmetically harming consequences. We can therefore significantly improve the quality of their life."

Thomayer Hospital in Prague

Aside from burn centres, financial assistance was granted to Thomayer Hospital in Prague which received a special device for laparoscopic surgeries on children. The hospital received the device at the beginning of 2013. It uses substantially smaller, thinner and shorter instruments which can be used even on newborns. "Laparoscopic surgeries on the youngest children are not as common as on bigger children and adults. However they might be desirable in the case of certain diagnoses. Examples includes congenital cryptorchidism, in the case of which the surgery is performed when the patient is approximately one year old. In addition, laparoscopic surgery is acceptable in the case of pylorostenosis or several other rare illnesses," says Professor Petr Havránek, Head Physician of the Department of Pediatric and Trauma Surgery of the 3rd Faculty of Medicine of Charles University and Thomayer Hospital.

Charity campaign supported by personalities

The project entitled A Child's Smile was supported by Ivana Gottová who attended the event. She and her husband, singer Karel Gott, are among the long-term supporters of the Our Child Foundation. Model Lucie Křížková was also there when the medical devices were presented to the Královské Vinohrady University Hospital.

A big thank you goes to the ROSSMANN company, its employees, suppliers and customers who have contributed to the success of the large-scale charity project for children.

POSITIVE PARENTING

The aim of the Positive parenting project is to reduce the alarming divorce rate among families with children and eliminate disputes and child custody lawsuits. The foundation organised edification seminars for professionals and the general public.

Restoration of the atmosphere of love aka Education without excessive punishment

The first of a series of all-day seminars was held on 9 January 2012 in Prague. Its topic was "Restoration of the atmosphere of love in families". The agenda of the seminar attended by 120 people included emotional confrontation as a necessary attribute of communication and reconciliation or the so-called firm hug as a new lifestyle.

Second edification seminar titled "Let's go together... with love" was held in cooperation with the Municipality of the City of Prague on 28 March 2012. It was attended by 70 people. The main aim of the seminar was to promote happy childhood for children and personal satisfaction for educators (parents or teachers). The main lecturers at both seminars were Jiřina Prekopová, Taťjana Horká and child psychologist Jaroslav Šturma (all of whom cooperate with the foundation on a long-term basis).

Seminars and edification DVDs produced by the foundation are well received. During the year 2012, director of the foundation Zuzana Baudyšová attended and spoke at various conferences and edification events organised all over the country (Brno, Vsetín, Jihlava, Prague). Most common topics included the protection of children, education and restoration of love in families.

GRANT PROCEEDINGS – FIF 2012

Civic associations, special-purpose facilities operated by churches and public service organisations active in the area of protecting children and their rights (with the exception of foundations) may apply for grant donations from the Foundation Investment Fund (FIF) every year.

The foundation redistributes revenues from the Foundation Investment Fund via a grant proceeding for the support of humanitarian projects and programmes in the field of child protection. Organisations and projects supported from the fund comply with the provisions of the Convention on the Rights of the Child. In 2012 the foundation received 67 applications for financial support in this grant proceeding.

In 2012 a total of ten projects were supported by CZK 244,475.

Redistribution of the financial resources from FIF was approved by the Board of Trustees of the foundation on 6 June 2012. These resources were represented by revenues from FIF for the year 2011.

Charita Česká republika, Most branch

church-operated legal entity, Most Project "Asylum home for mothers and their children" is aimed at helping mothers with children in life-affecting situations, e.g. victims of domestic violence.

Grant in the amount of CZK 18,000 approved

Daneta

citizen association, Hradec Králové Project entitled Therapy for the Handicapped aims to provide alternative therapies which exploit, to the maximum extent, medical, educational and relaxation effects on children and youth with combined handicaps (these methods include animal-assisted therapy, aroma therapy, art therapy, music therapy etc.) Grant in the amount of CZK 42,000 approved

Spondea

public service organisation, Brno Project entitled Asylum for At-risk Children addresses the issue of the care for children who live in special facilities whose clients require urgent care. The project entails services provided to children and their families consisting in non-stop psychological and social consultancy, including the opportunity to stay in a "crisis room". The aim of these consultancy services is to seek ways to avoid the placement of the child in an state-run asylum and give the child the opportunity to go home to his/her family. Grant in the amount of CZK 50.650 approved

Mirabilis

citizen association, Prague 4 Project entitled All-year Assistants for Handicapped Children provides volunteer assistants to families with children in life-affecting situations (disability, remote regions, social exclusion, etc.). Grant in the amount of CZK 12,000 approved

DEJME DĚTEM ŠANCI (Leťs give kids a chance)

citizen association, Prague 10 Project entitled Off To a Good Start aims to support children who, having graduated and/or turned 18, leave children's homes at the end of the academic year. This assistance consists in providing material support in the form of basic household necessities. Grant in the amount of CZK 20,000 approved

Středisko pomoci ohroženým dětem ROSA (Center for the care for at-risk children – ROSA)

citizen association, Kladno Project entitled Care for Handicapped Children and Their Families aims to mitigate the effects of the children's disability on their lives. This project includes skill development therapy, meetings of families with group programme for children and parents, relaxation programmes for families, psychological diagnostics and consultancy, consultations at the clients' homes aimed at the development of the child, video training of interactions and group therapy. Grant in the amount of CZK 21,825 approved

Středisko křesťanské pomoci – Pastelka (Christian help centre – Crayon)

church-operated legal entity, Protivín Project entitled Use Your Heart and Hands is aimed at edification and education based on the principles of unconditional love, empathy, understanding and tolerance. It also includes the acquisition of practical skills and knowledge in the spirit of the so-called positive parenting. Grant in the amount of CZK 17,000 approved

Občanské sdružení Rozum a cit (Sense and sensibility)

citizen association, Prague 7 Project entitled Therapeutic Summer Camp for Foster Families with Disabled Children includes the organisation of a summer camp for whole foster families who have a disabled child (children) in foster care.

Grant in the amount of CZK 13,000 approved

Kolpingova rodina Smečno (Kolping Family)

citizen association, Smečno Project entitled Emergency Housing for Mothers and their Children in the Family Centre in Smečno provides short-term (temporary) housing in Rodinné centrum Smečno (family centre) to mothers and children in life-affecting situations (pregnant women, single mothers (underage or without income), victims of domestic violence, social exclusion, homelessness).

INDIVIDUAL APPLICATIONS

Helping individual children is a key aspect of the mission of the Our Child Foundation. By providing help on an individual basis, the foundation tries to mitigate the recipients' physical handicaps or other disadvantage and make sure they can live full life despite the handicap.

In 2012 the foundation granted financial support based upon 108 approved individual applications in the amount of CZK 8,766,423.

Individual applications up to the amount of CZK 10,000 are approved by Zuzana Baudyšová. Applications exceeding this amount are reviewed and approved by the Board of Trustees of the foundation. All approved applications reflect the status and mission of the foundation.

OUR CHILD ACCOUNT

The general public may get involved in a long-term continuous charity drive, the proceeds from which are used for the aforementioned individual applications. All one has to do is create a standing payment order for a payment to be credited on a regular basis to the Our Child account number 123131123/0600, most commonly CZK 50, 100 or 500.

The Our Child account helps children whose lives are much harder than ours. They have to deal with a handicap or lifeaffecting situations. However, they do possess a remarkable zest for life. The foundation wants to support them as much as possible.

The account is set up as a "transparent account", which means everyone can see for themselves that 100% of the financial resources provided are provided to children in need. The account has so far been supported by numerous personalities. We would like to thank economist Tomáš Sedláček for his support or Lukáš Hejlík and Alan Novotný from LiStOVáNí.cz for their willingness to star, for free, in a clip based on the book Ekonomie dobra a zla (Economics of Good and Evil).

Thanks to contributions from the general public, the Our Child Foundation was able to support the following children:

Karolínka

Karolínka is two years old. Unfortunately, she was diagnosed with a rare condition known as hereditary spastic paraparesis which causes stiffness in lower extremities and damage to hip joints. Her legs often get crossed and she is unable to bend them or to sit upright. Her parents exercise with her on a daily basis, using the so-called Vojta method, and they attend physiotherapy sessions once a week. With the financial support from the foundation, her parents could purchase a special stroller in which Karolínka can sit properly and go on trips.

Linda

Linda (5) was born a healthy girl. When she was almost two years old, some health problems became apparent. Linda suffers from autism with psychomotor impairment, with other related complications – myopia, bad motor skills (frequent falls and injuries) and suspected palatoschisis. Despite this condition, she can laugh, she loves her sister, she likes kindergarten and takes music lessons. Thanks to the donations, her parents could buy a specially adapted car which they use to drive Linda to medical exams, to kindergarten and on trips.

Lukáš

Lukáš (15) is a smart and agile kid who lives full life despite his handicap. He enjoys computers. Lukáš is physically handicapped, currently on pulmonary ventilation. However, he wants to be independent. Since the first grade, he has been using an electric wheelchair. Due to spine-related problems he can only sit in it 30 minutes every day. His mom is trying to get him a MTM wheelchair in which he could lie and control it by cameras. We are glad we could help and we would like to wish the best of luck to the family.







Štěpán

When Štěpán (3) was nine months old, he was diagnosed with hypotonic syndrome, the symptoms of which include slower motor development. His mom is doing the best she can: she tries the Vojta method, she takes her son to speech therapy as well as to a rehabilitation programme every year. A physiotherapist recommended that she buy her son a special rehabilitation stroller. She can now purchase it thanks to financial assistance from the foundation.

Petr

When he was three years old, Petr was diagnosed with psychomotor impairment. At the age of three, all he can do is crawl. His mom takes him to rehabilitation sessions and practices the reflexlocomotion technique on him. They will certainly appreciate a special rehabilitation table purchased with donations to the Our Child account.

Martin

Martin was born prematurely (30th week) and was immediately diagnosed with cerebral palsy. All extremities have been affected, which means he cannot walk or stand and needs a special support to be able to sit upright. The whole family supports him, including his 17 year-old brother. The two are best friends. Martin attends a special school where he has all the attention he needs thanks to very enthusiastic teachers and assistants. He often joins other kids on field trips to museums and theatres. A special stroller and mechanical wheelchair, recently bought thanks to financial assistance from the Our Child Foundation, will make it much easier for him.

CHARITY DRIVE "LET'S HELP CHILDREN TOGETHER"

The Our Child Foundation regularly opens a transparent account within the framework of the charity drive entitled Let's Help Children Together, especially in cases when greater general public participation and involvement are desirable. In cooperation with the general public, the foundation tries to help atrisk children who desperately need help. A total of eight children were granted support from the proceeds from this charity drive in 2012.

Help for Tobíšek

The foundation responded to a complicated story of the Hammonds (Czech wife and Australian husband) whose disputes resulted in a complicated and costly child custody lawsuit. When the mother arrived in Australia (as ordered to do so by a Czech court), the police separated her from her son. Having checked the information provided by the father, an Australian court gave her her son back and the proceeding continued. The Our Child Foundation. in cooperation with the general public, granted Jana Hammond a financial contribution in the amount of CZK 356,787. The total legal expenses exceeded CZK 2 million. The foundation is well aware of the fact that it is not always easy to evaluate a particular case. However, the interests of the child are the most important thing for the foundation.

Speech processor for Vladan

Vladan (9) is deaf. Thanks to a cochlear implant, which he has been using for seven years now, he knows what it is like to hear the sounds of the world around him. His first speech processor had become obsolete; because of its design, Vladan was unable to do what other kids do. He used to have it attached to his body. It was connected to the cochlear implant via a long cable. Now he has a modern speech processor which enables him to do seemingly ordinary things, like carry a backpack, do some sports or sit on a chair. We would like to thank everyone who has donated money in this charity drive. Vladan received CZK 299,492.

Special mechanical wheelchair for Jana

Jana (3) was diagnosed with spastic diplegic cerebral palsy and ichthyosis. Her development is retarded and she cannot walk due to her condition. Therefore, she was only able to move on a rented wheelchair. Thanks to the proceeds from the foundation's charity drive Jana received a contribution in the amount of CZK 30.954 for an active wheelchair for children. She can use it to move on her own at home or outside. which has a positive impact on her mental development. Jana has recently had another surgery. In addition to allowing her to move around, the wheelchair will make sure Jana's legs are properly aligned so that she does not suffer from spastic contraction of ligaments.

The wheelchair is awesome. All my friends want the same one.

LEGAL AID LINE

The Legal Aid Line has been helping families and children in life-affecting situations since 2005. Specialised lawyers have since provided free-ofcharge consulting services to 2,259 clients (1,693 by phone, 566 by mail). The Our Child Foundation operates the Legal Aid Line in close cooperation with the Czech Bar Association. The association's help, consisting in the setting up of a team of experts in family law, is greatly appreciated.

Most inquires addressed to the Legal Aid Line are related to family law – divorces and post-divorce arrangements (arrangements with regard to the custody of a minor, failure to play alimony). Most clients are mothers, grandparents and fathers, but they also include unrelated family friends.

In 2012 the lawyers answered 181 questions. The range of these inquiries can be illustrated by the examples mentioned below:

International child custody disputes

The Our Child Foundation has been monitoring the increasing incidence of "international child custody disputes". More and more children whose parents are nationals of two different countries become the object of legal disputes. The common aspect of these stories is that one of the parents is Czech and the other is a foreigner. Under certain problematic circumstances (disputes, mental abuse) the child can be taken by one of the parents to their home country. Under the applicable law, it can constitute "parental kidnapping". Therefore, the priority of the jurisdiction of the habitual residence was established. It means that the child's living conditions shall primarily be decided by a court in the country where the family lived together prior to separation and the verdict of the court should be acknowledged by other countries. Jurisdiction should be the next step. These legal disputes are very lengthy, expensive and emotionally exhausting.

Child custody, contact and visitation

Typically, when parents break up, the custodial parent moves to another city. Even though the couple may have drafted a contract governing the conditions of access, contact and visitation, the custodial parent often fails to abide by the provisions of the contact and does not allow contact between the child and the noncustodial parent (and grandparents). There has never been any court ruling with regard to the circumstances of the raising and support of the child. Lawyers working for the Legal Aid Line explained the clients how to proceed with their petition and explained that even grandparents have the right to visitation/access (a court order can be sought in this regard).

Sexual exploitation

A desperate woman contacted the foundation and claimed she was worried about the well-being of her granddaughter. The woman claimed that her granddaughter, 5, had been sexually exploited. At that time the girl had already been in a mental hospital for some time. The woman asked about the possibility to get custody of the girl until the case was investigated. The lawyers recommended that she contact the competent authority concerned with social and legal protection of children. This authority would issue its statement approving or rejecting the granting of custody.



INTERNET HOTLINE SAFER INTERNET FOR CHILDREN

Overview of reports to Internet Hotline between 2007 and 2012

The use of new media isn't associated only with the easier sharing of information and easier communication. They represent increased risks as well. Victims of "cyber abuse" or child pornography especially include children who are curious and naive. This is why the Our Child Foundation is concerned with the issue of safer Internet and has established, for this purpose, an Internet hotline in 2007.

Thanks to the project entitled Internet Hotline, the general public may report any suspicious website. Operators of the hotline will review the website and report any dangerous content to the respective department of the Police of the Czech Republic and other authorities involved. The aim of the project is to eliminate websites containing dangerous or inappropriate materials from the Internet.

Due to the fact that the Internet does not respect state borders, the foundation participates in a global debate on the protection of children from the dangers of online technologies. The foundation is a member of an international alliance of NGO's, eNACSO (www.enacso.eu).

FOUNDATION AND MASS MEDIA

For the Our Child Foundation, mass media are important partners with regard to the efforts aimed at the general awareness about the protection of children. Director of the Our Child Foundation Zuzana Baudyšová appeared in mass media numerous times in 2012 (print media, television stations, radio stations, Internet) to discuss the current and long-term issues related to the protection of children in the Czech Republic.

The reports and articles in the media covered a broad spectre of issues, especially the statistics and particular cases of abused and sexually exploited children and the increasing incidence of child custody disputes between partners of two different nationalities. The Our Child Foundation held press conferences on both topics. The presence of the management of the foundation and other experts had a positive effect with regard to the media coverage of these topics. The problem of child custody disputes between partners of two nationalities is often underestimated. If not dealt with properly, any such dispute may result in very complicated life-affecting situations and legal battles that may last for years.


Mass media were, once again, interested in the charity project entitled A Child's Smile organised by the foundation's general partner, the ROSSMANN company. It included ceremonial handover of a special instrument for the burn centre of the Královské Vinohrady University Hospital and presentation of the forms of help to burn centres in Prague, Brno and Ostrava in the presence of Ivana Gottová and model Lucie Křížková.


In 2012, the foundation was referred to or mentioned in 488 articles. Regional press referred to or mentioned the Our Child Foundation most often (45% of the articles). Internet servers published 109 articles (22%), news agencies published 12% of the total number of articles. Traditionally, news reports in popular television and radio programmes and national dailies had the biggest effects. The Our Child Foundation wants to provide its services in all regions of the Czech Republic, which is reflected in the high percentage of articles in regional media. For example, regional media noticed the fact that Zuzana Baudyšová supported and attended a "march against child abuse" which took place in the town of Cheb. It was organised by Sonia Sudimacová, director of a local day care centre, and supported by the city hall and other institutions. In addition, media acknowledged Zuzana Baudyšová's speech at the 13th annual conference on socially pathological phenomena focused on bullying.

INTERNATIONAL ACTIVITIES

Protection of children is a global topic. Borders are eliminated especially thanks to the developing technologies. The Our Child Foundation actively participates in international debate and discussions and closely cooperates with numerous international organisations with respect to issues like missing children, safe Internet, protection of children from sexual exploitation and child prostitution etc.

Missing Children Europe

European Federation for Missing and Sexually Exploited Children (Missing Children Europe) is an association of 28 non-profit organisations from 19 EU Member States and Switzerland. Each member organisation is concerned with activities in the field of missing and sexually exploited children in its respective country, including prevention and intervention. The Our Child Foundation is a long-time member of this organisation. Director of the foundation Zuzana Baudyšová is a member of the Board of Directors. Missing Children Europe promotes a unified hotline for missing children throughout Europe -116,000 - which would provide comprehensive services to missing children. In addition, it promotes better legal instruments for child protection. This NGO is supported by the Belgian royal family and numerous personalities from various EU Member States.

Dragon boat races for charity

On Sunday 26 May 2012 a charity dragon boat race was held in Prague for the third time. The proceeds from the participation fee paid by the participating teams were divided among three nonprofit organisations: the Our Child Foundation, the Sananim citizen association and Život 90. The foundation had it own booth at the event. Thanks to kind sponsors, the foundation's team managed to sell sweet refreshments: honey care from the Cake Factory company and candy made by the Marcipánka confectionery. The proceeds went to at-risk children.

Golf tour helped abused children

A series of golf tournaments entitled Enjoy&greenstar golf tour 2012 earned CZK 226,000 for charitable purposes. The entire amount was used for renovation of a therapy room of a specialised centre that helps abused, sexually exploited and neglected children (CAN syndrome). Conditions were improved for children, psychologists, social workers and therapists. This amount was collected in cooperation with partners and players at six tournaments at various golf courses – Karlštejn, Austerlitz, Albatross, Kunětická hora, Karlovy Vary, Konopiště.

March against child abuse in Cheb

On the occasion of the World Day for Prevention of Child Abuse, a march took place in the town of Cheb entitled Stop Child Abuse. The event took place under the auspices of Mayor Pavel Vachoušek and Zuzana Baudyšová, who personally attended the event. Participants marched and blew whistles to express their protest against child abuse and molestation. This happening was a part of a project entitled Dětský úsvit (Brand New Start for Children) organised in the town of Cheb by the city-run day care centre led by Soňa Sudimacová, with the support from the city and other institutions. It also included workshops and radio programmes.

Letters to Santa

During Advent children from children's homes got their Christmas presents in the Europark Štěrboholy mall. Each visitor could pick one child's wish and make it come true by purchasing a Christmas present for the child. A total of 453 children from 14 children's homes found their present under the tree. Patroness of the foundation Helena Vondráčková performed at the event, as did children from the children's home in Býchory or the "Kocour Modroočko" dance company. The gifts were distributed free of charge, for the third time, by the GTL company.

New therapy room for abused children

The Our Child Foundation is worried to see the increasing incidence of child abuse and exploitation, due to which the victims need professional care. Therefore the foundation cooperates, on a long-term basis, with Dětské krizové centrum (Crisis centre for children), a respectable institution that provides complex psychological and social services to children. The foundation's efforts are aimed at increasing capacities and improvement of the services provided by the crisis centre. Thanks to financial support in the amount of CZK 313,000, a new specialised therapy room was introduced on 5 November 2012 by Zuzana Baudyšová and director of the crisis centre Zora Dušková. This new room offers children pleasant atmosphere full of colours, light and therapeutic toys. It is the best environment for therapy for clients and therapists.



Meeting of child protectors Golden Heart 2012 Award

In 2012 the Our Child Foundation celebrated its "19th birthday". It celebrated it with friends, partners and – of course – children. Over these nineteen years, the Our Child Foundation distributed over CZK 240 million for the benefit of abused, sexually exploited, disabled, abandoned or otherwise at-risk children.

Meeting of those who care about the protection of children took place in the Semafor Theatre on 1 October 2012. The programme of the foundation's "birthday party" included performance by Kolínbased Modroočko dance club. Talented pianist Jan Čmejla (9) played polonaise in G minor from Frédéric Chopin and Kabalevsky's sonatina in C major No. 3. The invited guests (friends and sponsors of the foundation) also enjoyed musical performance by Jiří Suchý and Jitka Molavcová from the Semafor Theatre. The event was emceed by Karel Voříšek. During the evening programme, the foundation traditionally presented the Golden Heart Award as a form of recognition of personalities who are concerned with helping children in lifeaffecting situations or people who promote the protection of children as a key public issue in the Czech Republic. The 2012 Golden Heart Award was conferred on the Office of the Public Defender of Rights led by the Public Defender of Rights Pavel Varvařovský and the Crisis centre for children led by its director Zora Dušková. The Our Child Foundation has great respect for these two institutions and their employees because of their continuous efforts in the field of child protection.

GOLDEN HEART 2012 AWARD

Dětské krizové centrum (Crisis centre for children), Zora Dušková, Director

Dětské krizové centrum, o.s. (DKC) was founded in 1992 as the first facility concerned with the care for abused, sexually exploited and neglected children. It provides comprehensive psychological and social assistance to children, teens and their families. The Crisis centre for children has been providing its services for twenty years. It has so far provided services to 5,000 at-risk children. It has been operating a help line named "Linka důvěry" for fifteen years. The leader of the team of the Crisis centre for children is Zora Dušková. She is a clinical psychologist who has worked for the centre since 1999.

Office of the Public Defender of Rights, Pavel Varvařovský, Public Defender of Rights

Since 2000 the institution of the public defender of rights has been protecting individuals from illegal acts by authorities and institutions. As such, it has come up with a initiative specially targeted at children and young people who seek help in life-affecting situations. The team of the Office of the Public Defender of Rights led by Pavel Varvařovský, the Public Defender of Rights, encourages young people to contact the office, regardless of their problem. Any problem has a solution. It can be easier if one has someone who can help. In 2012, children and teens contacted the Public Defender of Rights to seek advice with regard to school, parenthood (motherhood), family, healthcare, work or part-time jobs.

In 2012 the Our Child Foundation managed to achieve smooth progress for all its projects aimed at helping children at risk and to sustain stable financial management.

The Foundation adhered to the rule stipulated in its Statute for restricting its administration costs (up to 20% of its equity). The achieved administration cost value that includes overall costs incurred, including individual projects, is 18.60%. After subtraction of project costs with respect to projects for the benefit of children and families in life-affecting situations, the administration costs amount to only 7.59%.

In addition, the foundation secured the necessary level of funding from individuals and entities to fulfil the objectives and mission set out in its Statutes.

Independent auditor's report

Our Child Foundation Notes to the Financial Statements for the year ended 31 December 2012

I. Background

Description of the Accounting Entity

The Our Child Foundation ("the Foundation") was established on 1 October 1993. Its registered office is located at Ústavní 91/95, Prague 8, the Czech Republic, business registration number (IČ) 60166754. The Foundation is incorporated in the Foundation Register maintained by the Municipal Court in Prague, Section N, File No. 57.

The purpose of the Foundation is to support humanitarian projects which help to create an effective system of child protection in the Czech Republic and to ensure the protection of human rights within the Children's Rights Convention. The humanitarian projects are supported by the re-distribution of grants for programs aimed at reaching the Foundation's goals.

In addition, the Foundation aims to help children who find themselves in difficult life situations.

The Foundation supports and develops cooperation with international organizations active in the field of child protection and collaborates on joint projects with these organizations.

The Foundation's Promoter - Zuzana Baudyšová

The Foundation's equity in cash amounted to CZK 36,104 thousand as at 31 December 2012. The Foundation's equity comprises a government contribution in the amount of CZK 35,604 thousand contributed pursuant to agreements for the transfer of funds and addenda thereto determined in a resolution of the House of Deputies of the Parliament of the Czech Republic for the Foundation Investment Fund in the first and second stages and the Foundation contribution in the amount of CZK 500 thousand. The Foundation's equity is deposited with GE Money Bank, a.s. pobočka Praha, A/C No. 201645972/0600 (CZK 35,604 thousand) and and with Československá obchodní banka, a.s. – A/C No. – 154051281/0300 (CZK 500 thousand). In addition, last year the Foundation's equity was increased by movable items totaling CZK 191 thousand not entered in the Foundation's property. In 2012, the Foundation's equity was increased by movable items not entered in the Foundation's property in the amount of CZK 278 thousand. In 2012, the sum was reduced by the value of disposed assets and the annual depreciation charge totaling CZK 206 thousand. The Foundation's equity was increased by movable items not entered in the Foundation's property totaling CZK 206 thousand.

II. Information about accounting methods used and general accounting policies

- The Foundation uses accounting methods which are in accordance with the accounting regulations set by Act No. 563/1991 Coll. on Accounting, Decree No. 504/2002 Coll. as amended, and the Czech accounting standards for accounting entities whose main scope of activities is not business. The accounting period is one calendar year.
- Explanation Added for Translation into English

These financial statements are presented on the basis of accounting principles and standards generally accepted in the Czech Republic. Certain accounting practices applied by the Company that conform with generally accepted accounting principles and standards in the Czech Republic may not conform with generally accepted accounting principles in other countries.

Method of Processing and Keeping of Accounting Documents

The Foundation's double-entry bookkeeping is maintained by the tax advisor Helena Čmejlová, Identification number: 62389891. Accounting records are processed using the PREMIER software; they are filed in hard copy and electronically on CDs and internal hard-drive. The accounting documents are filed in the Foundation's registered office.

Valuation and Depreciation and Amortization of Assets

Purchased tangible and intangible fixed assets with a cost exceeding CZK 10 thousand are recorded at their acquisition cost, which consists of purchase price and other related costs. Fixed assets acquired for no consideration are valued at cost pursuant to donation contracts.

The depreciation of tangible assets and the amortization of intangible fixed assets are calculated based on the acquisition cost and the estimated useful life of the related assets. The useful economic lives are as follows:

Short-term financial assets consist of cash on hand and in bank.

- Receivables and liabilities are recorded at their nominal values.
- Valuation of Inventory

Purchased inventory is stated at acquisition cost including other related costs. Inventory acquired for no consideration is valued at cost pursuant to donation contracts.

Equity and Funds

Equity consists of monetary and non-monetary contributions, gifts recorded in the Foundation Register and tangible fixed assets acquired free of charge. In addition, the Foundation creates special-purpose funds for predetermined purposes in connection with the Foundation's activities set out in its statutes.

■ Foreign Currency Transactions

Since 2012, assets and liabilities whose acquisition or production costs were denominated in foreign currencies are translated into Czech crowns at the exchange rate prevailing as at the transaction date. In 2011, they were translated into Czech crowns at a fixed exchange rate corresponding to the Czech National Bank rate set on the first working day of the financial year.

On the balance sheet date, monetary items are adjusted to the exchange rates published by the Czech National Bank as at 31 December.

- Unrealized exchange rate gains and losses arising from translation of receivables and payables denominated in foreign currencies using the year-end exchange rate are accounted for in the balance sheet, at temporary accounts of assets and liabilities.
- Realized exchange rate gains and losses were charged or credited, as appropriate, to income for the year.
- Revenues and expenses are recognized on an accrual basis; that is, they are recognized in the periods in which the actual flow of the related goods or services occurs, regardless of when the related monetary flow arises.

Gifts Received and Provided

Received and provided financial gifts and contributions (including proceeds from collection accounts and their use) are accounted through the balance sheet, via funds using separate sub-ledger accounts. At the year-end, the adequate portion of the funds determined for covering project costs and Foundation's operations is transferred to income.

Non-cash gifts received in the form of a service are credited and simultaneously charged to income in the value stipulated in the respective contracts.

Income Tax

The corporate income tax expense is calculated based on the statutory tax rate and book income from primary and economic activities before taxes, increased or decreased by the tax non-deductible costs, revenues not subject to income taxes and revenues exempt from income taxes, using the tax relief for the taxpayers not founded or established for the purpose of carrying out business.

Summary of the management of proceeds earned from a contract for the transfer of remaining funds that, pursuant to the decision of the House of Deputies of the Parliament of the Czech Republic, are restricted to support foundations (NIF):

In 2012 and 2011, the Foundation deposited these funds on a term deposit account. In the period from 18 January 2011 to 31 December 2012 (due as at 13 January 2014) the funds were deposited at a term deposit account with GE Money Bank with the interest rate of 2.4% and in the period from 14 January 2010 to 14 January 2011 at a term deposit account with COMMERZBANK with the interest rate of 1.7%.

The interest accumulated on the term deposit with Commerzbank was CZK 857 thousand and CZK 849 thousand and was credited into income for 2012 and 2011, respectively.

In 2012 and 2011, the amounts of CZK 244 thousand and CZK 266 thousand, respectively, were redistributed pursuant to the contractual terms and conditions within grant proceedings from the NIF project. The remaining portion was used for the Foundation's administration.

Grant rules

The Our Child Foundation grant rules for awarding foundation contributions from the income of the Foundation Investment Fund in 2012

The purpose of the Our Child Foundation (hereinafter "the Foundation") is to support humanitarian projects which help create an effective system of child protection in the Czech Republic and ensure the protection of human rights in accordance with the Convention on the Rights of the Child. Humanitarian projects are supported by the provision of grants (foundation contributions) for programmes that serve to achieve the foundation's objectives. In addition, the Foundation seeks to provide direct help to children who find themselves in extremely difficult, life-affecting situations.

Conditions for awarding grants:

- 1. The aim of the project must be to protect children in the Czech Republic and/or it must be a project directly related to child protection, especially children who find themselves in difficult, life-affecting situations (children that are physically and sexually abused, mentally or physically disabled). Furthermore, the project must be aimed at preventing violence against children, including commercial sexual exploitation (e.g. child pornography, child prostitution, child trafficking), preventing negative phenomena in relation to children and young people and at implementing the Convention on the Rights of the Child into practice.
- 2. The applicant for a grant (Foundation contribution) must be a one of the following types of legal entity active in the area of child protection and children's rights:
 - legal entities not founded for the purpose of commerce, i.e. civic associations (o.s.), church legal entities (c.p.o.) (providing social, health, educational and cultural services) or public benefit companies (o.p.s.).

Exception to the list are legal entities where decision-making processes or general operation is done (be it actually or legally) directly or indirectly by members of the Board of Trustees of the Our Child Foundation, or members of its Supervisory Board, or employees of the foundation and their family members. Non-profit or subsidized organisations are also excluded.

- 3. Projects must be implemented in one year (twelve consecutive months), including the drawing up of the relevant budget.
- 4. Along with the application, the applicant must submit an original or certified copy of the certificate of registration (i.e. in the case of a civic association a certificate of entry in the Register of Civic Associations issued by the Ministry of the Interior; in the case of a public benefit company a certificate of incorporation in the Commercial Register issued by the competent regional court; in the case of a religious organisation an extract from the register kept by the Ministry of Culture; in case of a public legal entity another document proving its existence). The certificate of registration must not be older than three months, i.e. the issuing body has issued the certificate in a period of less than three months before the submission of the grant application.
- 5. Furthermore, the applicant must submit an uncertified copy of a document governing the internal terms and conditions of the organisation (e.g. the Articles of Association, Statutes).
- 6. In addition, the applicant must fill in an affidavit stating that members of the Board of Trustees of the Our Child Foundation or members of the Supervisory Board, employees and relatives of the aforementioned persons cannot influence, directly or indirectly, the decision-making processes or activities (factually or legally) of the organisation. This affidavit is attached to the application form.

Award procedure schedule:

- 1. The Foundation's grant program for each year shall be announced by the Foundation Director. It shall be published on the Foundation's website, or by other available means.
- 2. Applicants shall send one copy of their application, along with the necessary appendices and cover letter, to the address of the Our Child Foundation, Ústavní 95, 181 02 Prague 8. In addition, they shall send the application, without the appendices, by e-mail to m.maxova@nasedite.cz (along with the cover letter).

- 3. The closing date for submitting applications shall be on or before 31 March of the applicable calendar year (applications received after this date shall be discarded).
- 4. The Foundation shall keep records of all applications and shall perform a formal examination of them. Applications failing to meet all formal prerequisites shall be excluded from any further proceedings.
- 5. There shall be no legal entitlement to the contributions awarded by the Foundation. The foundation's Board of Trustees shall decide on the award of a foundation contribution based on recommendations of the Foundation's Board of Advisors.
- 6. The foundation Director shall initially provide her opinion on any and all applications received by the foundation and shall subsequently submit the application to the Board of Advisors.
- 7. The Board of Advisors shall familiarize itself with the application content and in compliance with the Grant Rules, the Board of Advisors shall assess and discuss the application and draw up its recommendation for the Board of Trustees. Should the Board of Advisors find an application to have substantial deficiencies, the application shall not be recommended to the Board of Trustees. The Board of Advisors shall justify its standpoint in an appraisal submitted to the Board of Trustees.
- 8. The Board of Trustees shall make the final decision on approving or rejecting the award of the Foundation funds to individual applicants.
- 9. The Board of Trustees shall subsequently return rejected and approved applications to the Foundation Director, precisely specifying the grant amount and the purpose for which the grant shall be used.
- 10. The foundation shall notify all applicants in writing of the conclusion reached by the Board of Trustees no later than within three months after the deadline for submitting grant applications (i.e. by 30 June). However, the foundation shall not be obligated to communicate the reasons for rejecting an application.
- 11. The foundation shall enter into a contract on the award of a foundation contribution with the applicants of all approved projects and shall secure the transfer of the funds according to the contractual provisions. By signing the contract, the applicant undertakes to co-operate with the foundation and grants his/her consent to the foundation to check the proper drawing of the allocated funds, i.e. the applicant agrees to submit reports on the project in the form of an interim and final report (containing text and financial). Costs incurred prior to the signing of the contract cannot be compensated. In other words, only expenses incurred after the signing of the contract will be remunerated.
- 12. As the grant provider, the Foundation reserves the right to perform continuous inspections, and should the grant beneficiary fail to meet the objectives of the project for which the grant was received, and/or should the grant beneficiary use the funds in a manner that is in conflict with the purpose established by the contract, the beneficiary shall return the funds to the Foundation.
- 13. The grant beneficiary shall submit a statement of funds to the Foundation within the time period specified in the contract.

Grant applications must comply with the following criteria:

- A completed application form containing information on the applicant must be submitted along with a cover letter.
- Up-to-date, original or certified (see above) copy of the certificate of registration not older than 3 months.
- Copy of the document governing the internal terms and conditions of the organisation (e.g. Articles of Association).
- Project description and schedule.
- Project expenses (budget).
- Exact specification of the contribution and its purpose.
- Overview of other funding applications submitted in relation to the project, including the amount.

Independent auditor's review report

To the Board of Administration of Nadace Naše dítě:

We have examined the usage of the 2011 Foundation Investment Fund income for the year ended 31 December 2012 (see Appendix 1) in accordance with "The Contract for the transfer of funds determined by Resolution No. 413 of the House of Deputies of the Parliament of the Czech Republic adopted at the 15th session 8/7/99 on the government bill for the distribution of funds attained by the sale of shares determined for the Foundation Investment Fund in the first stage" and "The Contract for the transfer of the remaining funds determined by the resolution of the House of Deputies of the Parliament of the Czech Republic for the purposes of granting support to Foundations in the 2nd stage, entered into under Section 18, paragraph 2, letter a) point 6) of Act No. 171/91 Coll.", (hereinafter referred to as the "the Contracts") – (see Appendix 2).

Board of Administration's Responsibility

The Board of Administration is responsible for using the Foundation Investment Fund for the foundation purpose as defined in the Contracts and for the separate maintaining of the accounting records in accordance with the Contracts and accounting principles generally accepted in the Czech Republic.

Auditor's Responsibility

Our responsibility is to express a conclusion about the usage of Foundation Investment Fund as of 31 December 2012 based on our audit. We performed our assurance engagement in accordance with the International Standard on Assurance Engagements. Those standards require that we comply with ethical requirements and plan and perform the assurance engagement to obtain reasonable assurance that the company meets the requirements contained in the Contracts and therefore our procedures included examining evidence based on samples as to whether the usage of the Foundation Investment Fund was incurred for the purposes specified in the Contracts, and whether separate accounting records were properly maintained in accordance with accounting principles generally accepted in the Czech Republic. Our audit procedures were limited to the disbursement of funds by the Foundation Investment fund to recipients and did not extend to the usage of those funds by the recipients for its intended purposes.

We believe that the evidence we have obtained is sufficient and appropriate to provide a basis for our conclusion.

Auditor's Conclusion

In our opinion, Nadace Naše dítě used, in all material respects, the Foundation Investment Fund for the year ended 31 December 2012 in accordance with the Contracts.
